At PracticeMyInterview.com, we value your privacy and are committed to protecting your personal information. This Privacy Statement outlines how we collect, use, and safeguard the information you provide when using our service, in compliance with the General Data Protection Regulation (GDPR) for users in the European Union.

### **Information We Collect:**

When you sign up for our service, we collect your first name and email address. This information is solely used to share your interview results with you.

During the interview process, a video recording is made, which is securely stored on our cloud storage partner. This video is automatically deleted 24 hours after completion. Additionally, the voice in the video is transcribed by a transcription service partner for analysis purposes.

### **How We Use Your Information:**

The video recordings are not reviewed by humans. Instead, we utilize artificial intelligence tools such as ChatGPT or Google Gemini to analyze the results based on prompts generated by our software. Once the video is deleted, both the transcript and any associated data are also removed from the transcription service, AI tools, and cloud storage.

The only data we retain is aggregate data, which includes the number of interviews conducted, anonymized job titles entered by users, and users' first names and email addresses. We do not sell this data. It is used for internal reference and to enhance our service, as well as to keep users informed about new features and functionalities. Users have the option to opt out of receiving communications from us.

### **Use of Cookies:**

We may use cookies on our website. These cookies may be used by our partners to push job notifications that you may be interested in or to display third-party advertisements. You have the option to control or disable cookies through your browser settings.

### **Third-Party Advertising and Sponsorships:**

We may display third-party advertisements or sponsorships within our app and on our website. These advertisements may be linked back to the advertiser's website. We do not provide any personal data collected from our users to advertisers.
